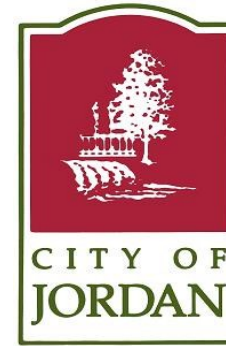

### Oath of Office Given to Mayor Velishek and Councilmember Oldenburg

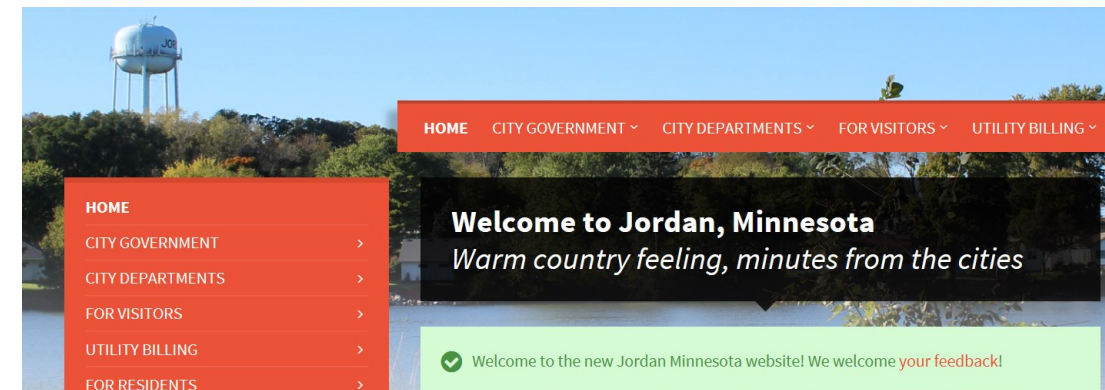

## Garbage and Recycling Survey Results

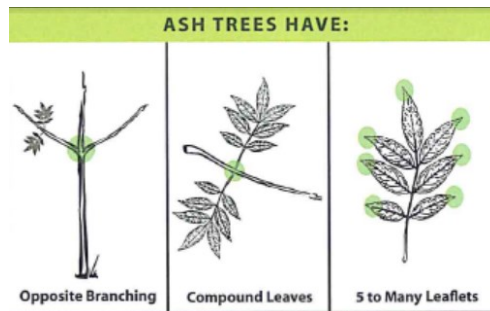
The City recently distributed a survey on garbage and below are the results. The City has 1,628 residential water accounts and 440 responses were received back which is 26%.

- 66.59% think the current recycling is fine
- 51.49% would like a second recycling cart at no charge
- 19.22% would like weekly recycling
- 29.26% use the yard waste pickup dates
- 24.94% are interested in organics
- 29.33% are using the spring and fall cleanup days
- 77.86% responded that they are happy with the current services

Council will review a draft RFP document in April prior to distribution to interested haulers. The current contract with Elite Waste expires December 31, 2016.

## Emerald Ash Borer

Do your trees have Emerald Ash Borer? First identify the tree! Emerald Ash Borer (EAB) are unique to Ash trees. Ash trees have opposite branches, compound leaves and 5+ leaves. There are three common symptoms of Emerald Ash Borer that you can watch for. Watch your Ash trees for woodpecker holes, bark cracks and the common S-shaped tunneling that is located under the bark. Watch for EAB in your yard and neighborhoods. This invasive species has killed millions of trees in the United States. ## 2016 Street Improvement

### Upcoming Street & Utility Projects

This summer the City will be completing work in six areas as part of its annual street and utility improvements program. These areas include:

- Mill Pond Area (Rustle Rd, Juergens Cir, Juergens Dr, Mill Pond Dr)
- Nolden Lane & Adams Lane
- Wood St, 3<sup>rd</sup> St to 4<sup>th</sup> St
- Crestview Circle
- South Broadway St (across Sand Creek from the Mini Met)
- Rice Street, 4<sup>th</sup> St to the Fire Hall

Construction is anticipated to occur in these areas between June and October. Work to be completed varies by area, but as a whole includes sanitary sewer replacement, watermain replacement, drainage improvements, and pavement resurfacing or reconstruction. The City is also in development of two other projects with potential to be constructed in 2017. The deck of the Varner Street Bridge over Sand Creek near downtown and Lagoon Park is in need of work. The City is currently developing plans to take advantage of potential State funding to make improvements to the bridge's width, railing, and pedestrian facilities. If State funding for bridges is expanded in this year's legislative session, the City hopes to take advantage of the funds and start work on the bridge in fall, 2016 or summer, 2017.

Finally, the City is currently considering developing plans for a new sewer line called the SW Interceptor along Highway 169. The project is proposed to be timed with pavement reconstruction on Valley View Drive in 2017 and installed under that roadway while it is rebuilt. Once installed, the interceptor will serve two primary needs for the City:

1. Relieve overburdened, existing sewer lines in the lowertown/downtown area to prevent backups
2. Provide sewer service to currently undeveloped areas along Highway 169, making development possible in these commercial and industrial areas

The City has secured \$180,000 in grant funding from the Scott County CDA for development of the project thus far and is continuing to look for other external sources of funding. Construction of the first phase of the interceptor is proposed for 2017 from the wastewater treatment plant to Scott CR 9.

# Things You Should Know

### DMV IMPORTANT NOTE

Minnesota law requires all owners to **provide insurance information** when registering, re-registering or transferring ownership of a vehicle. Information required: insurance company's name, policy number, and policy expiration date. **Tags cannot be issued unless the insurance information is available.**



### NITE TO UNITE

### FIRE HYDRANT FLUSHING

Public Works will be flushing hydrants starting in April through May. Keep an eye on the City's website and signs in your neighborhood for specific dates when the flushing will occur. If you have rusty water, turn on the outside faucets first and then all inside faucets and flush your system. The water should clear up in 10-15 minutes.



### YARD WASTE DATES

Elite Waste Disposal will provide yard waste and brush pick up on the following Saturdays: May 14th, August 13th, October 22nd, and November 5th. **You must use compostable bags.** Elite Waste Disposal will pick up bags of yard waste and bundles of brush curbside or in the alley. (Please ensure that all bags or bundles are out by 7:00 a.m.) Yard waste consists of grass clippings and leaves. Brush consists of limbs 6" or less in diameter and the bundles of brush can be up to five feet long and one foot wide. Valley Green yard waste is handled by a private contractor.

### DOG LICENSES

Dog licenses expired on December 31st. Dog tags are available at City Hall for \$10 for the calendar year. Please bring in your proof of rabies vaccination when you register your animal.

### BURNING PERMITS

Recreational Burning Permits are now available for 2016. Prices remain at \$20 for the calendar year. It takes a couple days to process the applications, so please plan accordingly.
